

MAKING A CODICIL

A codicil is a simple legal document which allows you to make changes to your existing will, without you needing to write a new will.

An example of how to make a codicil is shown overleaf.

As a codicil is a legal document, if you wish to make a codicil to change your will to add a legacy to Paul Strickland Scanner Centre would recommend you consult a solicitor to ensure this is done legally and correctly.

As a codicil is a legal document, we recommend you check with a solicitor if you want to change your will to leave a legacy to Paul Strickland Scanner Centre.

EXAMPLE CODICIL
